The parties to this contract are **Steel City Blues Society** (hereafter "Host") and _____ (hereafter "Vendor").

Whereas, Host is hosting an Event known as **Phoenixville Blues Festival** to occur at **Reeves Park, Phoenixville, PA on Saturday, September 7, 2019, beginning at 12:00 pm and ending at 10:00 pm**. Named Vendor has the right to license concessions to vend at and during the Event.

Vendor desires to vend: (please list food items)

at and during said Event, and Vendor has paid Host the sum of **\$200**.

The parties agree to the following:

1. Vendor shall have access to the location agreed upon by the parties no earlier than 9 am the day of the event for the purpose of setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location. Vendor should be up and running by 11:30 a.m. at the latest.
2. Vendor shall supply all tents, chairs and booths required for their services. Note that electricity will not be provided. Vendors requiring electric should provide their own source.
3. Vendor shall not vend any goods or services other than those described herein at and during the Event without the Host's written consent.
4. **Vendor must secure a valid Chester County license to serve food (contact Chester County Health Specialist at (610) 344-4462 – <http://pa-chestercounty.civicplus.com/index.aspx?NID=886>). Vendor's operation must be clean and orderly; and must comply with all applicable laws and regulations.**
5. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
6. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
7. No loud music, noise, or sound amplification devices shall be used by vendor's staff at the location.
8. Vendor shall have access to the location for up to 2 hours after the Event's conclusion to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
9. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor's presence at the Event and Vendor's activities of any kind.
